Regular and Special Programming:

Children's – Baby Story Time met 3 times with 17 in attendance. The Pre-K Story Time met 1 time with 9 in attendance. The Crafty Kid StoryTime met twice with 38 in attendance.

East Rochester Fire Department Monthly Village Board Report

August 2012

Village Board Members,

I am pleased to report the following activity for the East Rochester Fire Department during the month of July;

- We had an extremely busy month of July. We answered (44) alarms for the month bringing our year-to-date alarm total to (238). Out of the many alarms we answered, three of them were structure fires.
- On July 2nd we responded to 123 W. Filbert St for a report of a shed on fire in the back yard. Upon our arrival we discovered that the fire had spread from the shed in the rear of 123 W. Filbert St to an attached garage behind this address at 124 West Ave and to another detached garage at 126 West Ave. Our firefighters were on location within minutes and had the fire knocked down quickly minimizing the fire damage to the exposed structures.
- On July 14th we responded to 1051 Fairport Rd for a report of smoke coming from the roof of the house. Upon our arrival we found the single story residence charged with smoke. Our initial crews made entry into the house and upon searching the residence discovered an unresponsive occupant in a back bedroom. The firefighters removed the sole occupant from the residence who was later found to be deceased. The fire in the residence was found to have originated in the basement and was quickly extinguished with minimal spread into other parts of the house. It was learned following this incident that the occupant of this residence had died from causes unrelated to the fire. This was a highly stressful incident involving not only fire suppression efforts but a recovery of a victim from within the residence. I am proud to say that all of our firefighters and the firefighters from our mutual aid companies from Fairport, Penfield and Pittsford who assisted us at the scene this day did an outstanding job and I commend their actions during this difficult situation.
- On July 19th we responded to 2808 Baird Rd for a report of a garage on fire in close proximity to the residence. Upon our arrival we found the two car detached garage actively burning within several feet of the residence. Once again our firefighters made a quick knock down of the fire eliminating any fire spread to the exposed residence. The garage and contents sustained heavy damage as a result of the fire.
- In addition to our own alarms, we provided equipment and manpower for (9) mutual aid calls to the Fairport Fire Department, Penfield Fire Department and Brighton Fire Department.

JULY 2012

07/02 A tenant of the Capri Apartments at 400 Main Street was arrested after she smashed the front door causing the glass to break. She was arrested for Criminal Mischief, and Public Intoxication.

07/04 Three East Rochester youths were arrested under the curfew for being out after 11:00. They were issued an appearance tickets and taken home to their parents.

07/05 A Pine Street resident reported that someone threw a beer bottle through her window smashing the glass. No Witnesses.

07/06 The Police department was conducting a sobriety checkpoint on Fairport Road, which yielded an intoxicated driver. He was charged with Driving While Intoxicated, Unregistered Motor Vehicle, and driving with an Open Container of Alcohol.

07/08 During a routine traffic stop, a driver was also charged with Unlawful possession of Marijuana.

07/08 An East Rochester resident was charged with driving with a loud car stereo, in violation of the Village Ordinance, and issued an appearance ticket.

07/09 Three East Rochester juveniles were charged with Criminal Mischief Fourth, after being identified by an eye witness who saw them smashing lawn ornaments and outside lights from various houses on Magnolia Avenue. They were issued appearance tickets for Monroe County Family Court.

07/09 The Little League concession stand in Eyer Park was broken into. The cash register was removed, along with multiple candy bars. The burglary is under investigation.

07/10 A Garfield Avenue resident reported that her son bike was taken from the basement while they were in the process of moving.

07/10 An East Rochester resident was arrested for shoplifting from Wegmans at Country Club Plaza, and charged with Petit Larceny.

07/10 A South Washington Street resident reported that a neighbor called and had found a briefcase containing paper work in his name in her back yard. He reported his laptop computer as missing from the case.

07/12 A domestic dispute between father and son resulted in the son being arrested for Assault 3rd.

07/13 A Rochester man was arrested for being in the park after hours, it was also discovered that he had a warrant out of Brighton Police, he was issued an appearance ticket to East Rochester court and turned over to Brighton Police.

07/14 A Pine Street resident who is 16 years old was arrested for a curfew violation. He was issued an appearance ticket to East Rochester court, and his parents were sent a warning letter.

07/14 While attempting to make a Mental Hygiene arrest for attempted suicide, the other person living at the residence attempted to stop the officers from making an arrest by pushing them down the stairs. She was charged with Resisting arrests and Harassment 2nd.

07/15 Police responded to a burglary in progress call from 911 to the 300 block of west Avenue. Upon arrival the officer s could hear loud banging coming from the front door, and two people exited the porch. They were both placed under arrest and charged with Criminal trespass 2nd. They attempted to kick down the front door, but did not gain access. One of the suspects was a former girlfriend.

07/17 A mother of an East Chestnut Street youth called the police to turn in drug paraphernalia she had found in his room. She was directed to family court for help.

07/18 Two males entered Wegmans and took two six packs of beer. When they realized they were being followed by security, they broke up one of the packs and left the bottles along the isles of the store, and left with the other six pack in a backpack. Both were identified by cameras and arrested for Petit Larceny and Criminal Mischief 4th.

07/18 While on routine patrol, an officer pulled over a suspicious vehicle with four occupants. It was determined the driver was in possession of marijuana. He was charged with UPM.

07/20 An East Rochester resident reported that her purse was stolen after she left it on the front seat of her car, when she ran into the Dollar Store for a minute. A search of the area did not locate her property.

07/20 A sixteen year old East Rochester was charged under the Curfew law for being out on the street after 11:00. He was issued an appearance ticket for court.

07/21 Police approached a vehicle parked in the Piano works Mall at 3:00 in the morning. The passenger gave a false name, and was later identified as having an active warrant out of Gates. She gouged a female deputy in the arms, and kicked another officer as she was being taken into custody. She was charged with Harassment 2nd (two counts) and False Personation. She was turned over to the Monroe County Jail.

7/22 East Rochester police responded to a loud noise complaint. The resident was charged under the Village Noise ordinance after she repeatedly yelled at the police officers that she wasn't going to buy any more crack.

07/22 A routine traffic stop, yielded an arrest for Unlawful Possession of Marijuana. In addition, the officers found a loaded rifle in the vehicle. The rifle was confiscated, due to an Order of Protection against him which stated he could not have any guns in his possession.

07/23 Tim Horton on West Commercial Street reported that a man entered the drive through, ordered some food and then handed a fake 20 dollar bill to the cashier. The cashier immediately recognized it as fake, and the man drove off. The Secret Service responded and took possession of the bill.

07/25 Officers were called to a location for several males fighting. Witnesses were able to assist officers with the 17 year old male that attacked another male, he was arrested and charged with assault. An order of protection was issued for the victim.

07/26 Police responded to East Elm Street for a report of a fight in progress. Upon arrival they observed three males fighting in the street. One of the males was arrested for Assault 3rd.

07/28 A 17 year old male was issued an appearance ticket for curfew violation.

07/28 A 911 caller reported that his neighbor had been mugged by 2 males that were hiding in his apartment when he arrived home. They had left by the time the police had arrived. The front door was cracked open when the victim and a friend arrived home. A laundry basket full of victim's electronics was located on the floor near the front door. One of the burglars then ran out the front door and the victim ran after him. Unable to catch him, victim retreated when he encountered the other male suspect. The suspect pulled out a knife, and threatened the victim and then ran away. The suspect's descriptions were broadcast a perimeter was set up in the area. Witnesses assisted officers in locating the male suspects. The Sheriff's Dept. later located him near Whitney Rd. and Linden Ave. The victim and witnesses were able to positively identify him. During the arrest interview, a voluntary statement by the suspect in custody yielded the identity of the 2nd suspect. Investigation continues.

07/29 Several areas of the village have fallen victim to graffiti, and the village DPW has reported numerous stop signs and graffiti on the Lincoln Road underpass.

07/30 An employee in the accounting office at Wegmans found 3 counterfeit \$50.00 bills. US Secret Service picked up the counterfeit currency and will conduct the follow up.

07/30 The Technoplex mall reported that the north side of their building was covered with graffiti overnight. No witnesses.
