East Rochester Volunteer Ambulance Corps, Inc. monthly report for February 2011

- The East Rochester Volunteer Ambulance Corps, Inc. received 109 requests for service in the month of February and answered 71 of them for a 65% call coverage. Of the calls responded to 2 were by first responders, 12 were cancelled
 - ERVAC took 12 calls out of district for our neighbors.
 - ERVAC currently has 32 members on our roster. We have 22 members who are cleared to medic a call, 19 who are cleared to drive a call, of those numbers 17 are able to do both positions. We have 3 members in training. 3 members on medical leave and 4 members who are non running and help where needed.
1. So far this year, the ambulance corps has exceeded the record number of calls in January and February than any previous year.
 2. We completed our mandatory blood borne/hazmat training in February.
 3. We assisted the ERFD with a house fire on Linden Ave.
 4. The county is holding a core refresher course for all EMTs at our base on Tuesday and Thursday nights in March.
 5. We are in need of volunteers on all shifts, especially days and overnights. Anyone interested in volunteering their time should contact the East Rochester Ambulance Corps to inquire about opportunities and monetary incentives. Please call 586-5723 for more information.
 6. The 32 members of East Rochester Volunteer Ambulance Corps, Inc. are ready to help you with your emergency needs.

FEBRUARY 2011

- 2/01 A warrant for Criminal Contempt 2nd was advised for a Macedon man who repeatedly keeps calling ex-wife and wants to talk to her. He was in violation of an no contact Order of Protection.
- 2/02 ~~While on routine~~ patrol, an officer noticed an apparently intoxicated male walking down Main St. He refused to stop after several commands. The officer suspected he was trying to conceal something, so he handcuffed the male and discovered a gravity knife in his pocket .The male was arrested for Criminal Possession of a Weapon 4th and Public Intoxication.
- 2/02 A resident was seen crossing the CSX Rail Road tracks. While crossing, he stumbled several times and had trouble keeping his balance .While detained by the officer, marijuana and a pipe were located .He was arrested for Trespassing; Public Intoxication, and Criminal Possession of Marijuana.
- 02/04 A Magnolia Avenue resident reported that during the day while she was at work and her daughter was home alone sleeping, someone jimmed the door on her apartment and gained entry; the daughter awoke and thought it was her mother, so she did not investigate. Unknown what was taken at this point. The investigation will continue.
- 02/05 The East Rochester Fire Department responded to a house fire on Linden Avenue. The home owner had burned a potato in the microwave oven, setting the paper plate it was on fire. The homeowner took the burning plate out to the rash on the back porch. About an hour later she realized that the back porch was on fire and the flames were spreading up the back wall of her house. She escaped with her dog, but was unable to go back into her house to get her cats. Four cats died in the fire. The Red Cross provided shelter to assist the homeowner
- 02/06 A Penfield resident was arrested for violating an Order of Protection twice by leaving things on his ex-wife's car while she was at work in East Rochester. He was charged with two counts of Criminal Contempt 2nd.
- 02/06 An East Elm Street man was arrested when he stood in the middle of the street, refusing to move for traffic. He was charged with Disorderly Conduct, and issued an appearance ticket to court.
- 02/07 Several East Rochester High School girls reported being harassed on Face book by a fictitious person named Amy Fisher. The School Resource Officer is currently investigating to discover who the suspect really is. The investigation will continue.
- 02/11 While on a routine traffic stop for an expired inspection sticker the officer observed a marijuana pipe on the front seat. The driver was also arrested for Unlawful Possession of Marijuana.
- 02/12 An East Rochester resident was pulled over for a loud car stereo. He was issued an appearance ticket for ER Court.
- 02/13 Enterprise rent a car reported that an East Rochester resident never returned the car they rented, and has refused to pay for it. An arrest warrant has been issued for Unauthorized Use of a Motor Vehicle 3rd.

- 02/17 A 90 yr. old East Rochester woman was robbed in the parking lot of Big Lots on Fairport Rd. She was assisted by a shopper who had just come out of the store. Officers responded and an ambulance was dispatched as the woman was in severe pain. The woman had been pushed to the ground, while the suspect reached into her purse removing her wallet and car keys. An ambulance responded and took her to the hospital.
A description of the suspect was broadcast county wide and both East Rochester and Sheriffs cars responded along with the k-9 dogs. The wallet was later discovered along Washington Road in Pittsford. The woman suffered a fractured femur and remains hospitalized. The investigation is continuing.
- 02/20 A West Spruce Street resident reported that his double pane picture window was damaged by an unknown suspect using a bb gun. No witnesses.
- 02/22 A landlord of a Pine Street apartment complex reported that 16 feet of copper piping was stolen from the basement of his residence, along with a Bow Flex exercise machine. The rear of the apartment was vacant, and the front apartment residents did not see anything suspicious.
- 02/23 A domestic dispute resulted in a male being hospitalized after he became irate and drank bleach. He was taken into custody and transported to the hospital for mental evaluation.
- 02/23 An East Rochester resident was assaulted by another resident after they got into a confrontation in front of a Main Street bar. The suspect pushed the victim, causing him to fall over backwards, striking his head on the pavement. The suspect fled the scene, but was picked up soon after and arrested for Assault 3rd.
- 02/26 East Rochester police were responding to a reported Motor vehicle accident in which a vehicle had been rear ended by another car. Upon arriving on the scene and checking the driver of the striking vehicle, She was observed to be intoxicated. The drivers was put through a series of tests, all of which she failed. She was charged with DWI, DWI for a Blood alcohol content of over.08 percent, and DWI for a Blood alcohol content of over.18 percent. She was issued an appearance ticket for ER court.
- 02/28 An East Rochester man turned himself in on an arrest warrant for Petit Larceny. He was taken to jail on 500.00 cash bail.

There were 1,076 calls in the month of February. The police officers wrote 148 Traffic Tickets and 85 Parking Tickets. There were 2 Driving While Intoxicated arrests, one involved in a motor vehicle accident. Our Traffic Control Guard at the school was struck and knocked down while in the intersection directing traffic. He was taken to the Hospital and suffered from scrapes, a dislocated finger, and fractured shoulder. The female driver who hit him was charged with Aggravated Unlicensed Operation of a Motor Vehicle; Leaving the Scene of a Personal Injury Accident, Reckless Driving, and Failure to Obey a Traffic Control officer. The Chief of Police would like to remind everyone that the Crossing guards, and the Traffic Control guard is there to get your children to school safely every day. On inclement days, when a lot of parents are driving their children to school, please expect some delays getting into the school loop. Please consider dropping off your children in the designated area of the lower parking lot instead, to help ease the congestion.
