### East Rochester Volunteer Ambulance Corps, Inc. monthly report for May 2011

- The East Rochester Volunteer Ambulance Corps, Inc. received **88** requests for service in the month of May and answered **67** of them for a **76%** call coverage. Of the calls responded to **1** was by first responders, **6** were cancelled. Of the calls we missed, **8** were due to no backup crew.
  - ERVAC took **15** calls out of district for our neighbors.
  - ERVAC currently has 34 members on our roster. We have 19 members who are cleared to medic a call, 18 who are cleared to drive a call, of those numbers 15 are able to do both positions. We have 5 members in training. 5 members on medical leave and 3 members who are non running and help where needed.
1. We voted in 2 new members in May and are processing applications for 2 members to be voted on in June.
  2. We are in need of volunteers on all shifts. Anyone interested in volunteering their time should contact the East Rochester Ambulance Corps to inquire about opportunities and monetary incentives. Please call 586-5723 for more information.
  3. Our annual fund drive is currently underway. If you wish to donate to the volunteer ambulance corps, you can do so by mail to 254 West Ivy St.

MAY 2011

05/02 A domestic dispute, between two sisters resulted in a referral to Child Protective when they fought over the custody of a 10 month old baby. Child protective will follow up.

05/02 A Woodbine Avenue resident reported money missing from her house, there were several people over visiting over the weekend. The investigation will continue.

05/03 A West Elm Street resident reported that two bikes were stolen off her open front porch overnight. The bikes were locked.

05/03 East Rochester Police Responded to an unattended death on East Maple Avenue. The medical Examiner responded and pronounced the victim dead; however there were several marks on her head which were suspicious. An autopsy revealed that she had died of natural causes, and she fell upon a dresser, before she died. Case closed

05/06 Patrols responded to the Red Apple Mini mart for a customer trouble. The customer had used her credit card to pay for gas, but before pumping any, she replaced the pump back in the cradle to remove the gas cap. She was automatically charged for \$55 dollars on her card, and didn't get any gas. The officer explained to her she would have to contact her credit card company with the receipt to get her credit, but she wanted the store to give her \$55.00. A friend responded and got some gas for her.

05/07 While on traffic detail on West Commercial Street the officer observed a car go past at 47 MPH. Upon stopping the vehicle, the driver was obviously intoxicated. He was charged with Speeding, and Driving with a Blood Alcohol content over .08%, and Felony DWI-Previous conviction within the last 10 years.

05/07 A male was observed hanging around Edmond Lyon Park at 2:00am. He was charged with being in the park after hours, and issued an appearance ticket.

05/07 A wallet was stolen from an unlocked car parked in the 200 block of Garfield Ave. The wallet had been left on the seat.

05/07 While on routine patrol, an ER officer observed a Black male pulling a ski mask off as he was leaving Tim Hortons on West Commercial Street. The suspect began running, and as the foot chase began the Police radio indicated that Tim Hortons had just had an armed Robbery. The suspect he was in pursuit of matched the description given over the radio. The officer observed the suspect attempt to reach in his pocket as he was running away, so he fired his Taser, bringing the suspect to the ground. Another ER officer responded and the suspect was taken into custody. The suspect had large amounts of cash sticking out of his pockets and was in possession of a bb gun which closely resembled a real firearm. Upon further investigation an occupied vehicle was found less than a block away. The driver did not have a legitimate reason for being in the parking lot, but would admit to anything. The original suspect was charged with Robbery 2<sup>nd</sup>, and Grand Larceny 3<sup>rd</sup>. He had just been released from prison on April 7<sup>th</sup> for Robbery charges. He was remanded to jail on no bail status.

05/08 A West Hickory Street resident reported that at approximately 4:30 in the morning she heard a loud crash downstairs. Upon investigating the noise she found her front door window smashed, and a rock lying on the floor inside.

05/09 A female who was walking down West Chestnut Street at 9:50 at night reported that a male jumped out of the bushes and grabbed her by the arm stating "you know you want to come with me." The female pulled away, and immediately called her parents to come get her. She could not give a good description of the suspect. Police responded and canvassed the neighborhood with negative results.

5/09 The police were called to remove a runaway juvenile that occasionally sleeps on their porch. Before being transported, a pat down revealed a cell phone that did not belong to him. This was confirmed by the suspect's mother. He had stolen it from the earlier location and the homeowner did not have time before work to call the police. The juvenile was arrested for Criminal Possession of Stolen Property 5th.

05/10 A Fairport resident turned himself in on an arrest warrant, for a domestic dispute that occurred in April. He was charged with Assault 3<sup>rd</sup>, and Criminal Obstruction of Breathing. He was issued an appearance ticket and given an order of Protection issued by our judge.

05/11 An East Rochester resident called 911 to report numerous harassing phone calls from a former employee. The suspect was located at a nearby tavern and taken to ERPD for processing. While in custody, it was determined that suspect also had an arrest warrant in Jefferson County and they would extradite a pick up for their warrant.

5/12 Vincent Automotive called to report that 4 vehicles had been damaged by an apparent sharp instrument all to their side doors and trunks. The vehicles were parked off site and will now be relocated because it has become a common occurrence.

5/14 An ER Ambulance was called for a man that became unconscious while getting a tattoo. Officers responded and recognized the patient as a dangerous suspect. He was found to possess a black dagger hidden in the small of his back. ER Officers followed the ambulance to the hospital where they took the suspect into custody upon being medically discharged. He was charged with Criminal Possession of a Weapon.

5/16 A resident called to have police remove a juvenile that was sleeping on his porch without permission. The porch door was also found to have a small hole in it that wasn't there prior to homeowner locking it the night before. The juvenile was arrested for Criminal Trespass and Criminal Mischief 4th.
