### East Rochester Volunteer Ambulance Corps, Inc. monthly report for August 2011

- The East Rochester Volunteer Ambulance Corps, Inc. received **88** requests for service in the month of August and answered **48** of them for a **54%** call coverage.
- Of the calls we responded to **13** were cancelled. Of the calls we missed, **2** were due to no backup crew.
- ERVAC took **9** calls out of district for our neighbors.
- ERVAC currently has 34 members on our roster. We have 19 members who are cleared to medic a call, 17 who are cleared to drive a call, of those numbers 15 are able to do both positions. We have 4 members in training. 3 members on medical leave and 3 members who are non running and help where needed.
- Beginning September 1<sup>st</sup>, ERVAC has started using contract staff from the Southeast Quadrant ALS agency to help staff the ambulance on days when we cannot secure a crew. They are currently being staffed on weekends.

08/01 An East Rochester mother reported that her son has been receiving inappropriate text messages and calls from an adult male he met while playing x box games on line. The adult appears to live in San Antonio, Texas. The East Rochester Police and San Antonio police are continuing this investigation.

08/01 A Magnolia Avenue resident reported that her teen age daughter had been illegally tattooed by a "friend" who lives in Fairport. The investigation will continue.

08/01 Police responded to a report of a male sleeping in a driveway on Woodbine Ave. Upon arrival the officers discovered he had an open bottle of beer and was intoxicated. While being taken into custody, he was found in possession of heroin and cocaine. He was charged for Public Intoxication under the Village Ordinance, Unlawful possession of Marijuana, and Criminal Possession of a Controlled Substance.

08/03 A domestic dispute on West Maple Avenue resulted in two arrests. The Male was charged with Criminal Mischief 4<sup>th</sup>, and Harassment. The female was charged with Harassment.

08/04 An East Chestnut Street business reported that the rear door was pried open and several pieces of equipment were stolen. No suspects at this time.
