#### Public Comment

Rosalie Rosini, 210 E. Linden Ave., thanked Administrator Marty D'Ambrose and Police Chief Steven Clancy for attending a meeting at Northside Park with a small group of residents who had some ideas about improving the park. Concern over speeders on Magnolia Ave. was also mentioned as a concern.

Margot Gilhart, 220 Northwood Ave., spoke on the following items:

1. She congratulated Ed Parrone, Dave Bussey, Villager Construction, and others for a great job on the Park Drive Reconstruction Project.
2. She asked the Board to consider dedicating one DPW employee to park maintenance, as well as hiring part-time summer help to work/mentor under Mr. Rossi.
3. She also thanked Mark McDermott and Kathy Warren for their input in designing the layout for newly planted trees in Edmund Lyon Park.

Dan Rischenole, 115 Lincoln Mills Rd., suggested moving the double yellow lines on Main St. closer to the east side of the street.

Mark McDermott, 124 E. Ivy St., Parks Committee Chairperson, appealed to the Board for their help in "taking back" Northside Park from the "wrong element". He submitted survey results to the Board to give them more insight into the concerns of Northside residents and some of the problems that need to be addressed.

### East Rochester Volunteer Ambulance Corps, Inc. monthly report for September 2011

- The East Rochester Volunteer Ambulance Corps, Inc. received **102** requests for service in the month of September and answered **71** of them for a **70%** call coverage.
  - Of the calls we responded to **6** were cancelled. Of the calls we missed, **5** were due to no backup crew.
  - ERVAC took **19** calls out of district for our neighbors.
  - ERVAC currently has 31 members on our roster. We have 19 members who are cleared to medic a call, 18 who are cleared to drive a call, of those numbers 14 are able to do both positions. We have 3 members in training. 1 member on medical leave. 3 members are on student leave while attending college. 3 members are non running and help where needed.

- 09/03 A domestic dispute resulted in an order of protection for the female after the male threatened to cut her face with a razor. The arrest warrant has been signed by a judge.
- 09/04 Several vehicles on Ontario Street had their windows smashed with bricks.
- 09/05 A Penfield resident was charged with Aggravated Unlicensed operator, Failure to Yield the Right of Way, and leaving the Scene of an Accident when he fled the scene after striking another moving vehicle at the intersection of Washington and W. Commercial St .
- 09/06 A truck at the Department of Public Works had its window smashed out overnight.
- 09/08 Police responded to a customer trouble at Village Fair. The customer was intoxicated and abusive. He was found in the street where he had fallen down. He threatened the officer with violence, and was charged with Public Intoxication, Resisting Arrest, and Disorderly Conduct. He was arraigned in front of a judge and taken to jail.
- 09/09 A W. Chestnut Street resident reported that someone entered his locked garage overnight by breaking a window, and stole 6 cans of florescent pink spray paint. The paint was in a locked cabinet. Several fingerprints were obtained for processing.
- 09/10 Police pulled a car over for speeding on Fairport Road, and the driver was intoxicated. She was charged with Moving from Lane Unsafely, DWI, and Aggravated DWI .
- 09/11 A large party that refused to quiet down resulted in the arrest of a resident on West Elm Street. He was charged under the Village Noise Ordinance.
- 09/12 A business on North Washington Street reported having the window of their delivery truck smashed out.
- 09/13 A domestic c dispute on Cedar place resulted in the male half being arrested for Assault 3<sup>rd</sup> after he punched the female repeatedly in the face. He was transported to the Monroe County Jail.

09/14 Three East Rochester males in the 100 block of West Elm Street were arrested under the village Noise

Ordinance after have a loud party at 12:30 in the morning. They were all issued appearance tickets.

09/14 The East Rochester Schools reported that a science scale was missing from a classroom. Unknown when it actually disappeared.

09/16 While checking the North Side Park, an officer observed a man sitting on a bench smoking Marijuana. He was arrested and issued an appearance ticket for Unlawful Possession of Marijuana.

09/16 A routine traffic stop yielded an arrest for Unlawful Possession of Marijuana.


