## OCTOBER 2011

---

- 10/01 An East Rochester resident was arrested for shoplifting beer from the Red Apple on North Washington Street. He was charged with Petit Larceny.
- 10/01 A domestic dispute between father and son resulted in the son being arrested for Criminal Mischief 4<sup>th</sup> after he ripped the screen door off its hinges.
- 10/1 A Rochester resident was arrested for Public Intoxication after he was observed urinating on the corner by a police officer.
- 10/02 A Penfield resident was arrested for Aggravated Driving While Intoxicated, Driving while intoxicated, and Speeding after going past the officer doing 52 in a 40 mph zone.
- 10/04 A family trouble call on West Hickory Street resulted in the arrest of two brothers who injured their oldest brother during a physical fight inside the home. Both younger brothers were charged with Assault 3<sup>rd</sup>. The oldest brother had to be transported to the hospital due to loss of blood, and was treated and released.
- 10/05 A Pine Street resident was arrested for discharge of a firearm within village limits after he drove around the village firing paint balls at garbage cans and struck a vehicle parked in the road.
- 10/07 A West Commercial St. resident reported that while he was on vacation someone entered his apartment and stole a 19 inch flat screen TV and some video recorders. The burglary was discovered by a friend who came to collect his mail.
- 10/07 An East Rochester female was arrested for Stalking after she posted obscene observations on her face book and emailed it to all of his fellow employees. She was issued an appearance ticket, and an order of protection was issued to her victim.
- 10/08 While on routine patrol our officers observed a vehicle pass him. The officer ran the registration and suspected the vehicle was being operated by a person who had an arrest warrant with East Rochester. Upon pulling the vehicle over, the officer realized that the driver was intoxicated. He was charged with DWI, and taken in on an arrest warrant for Sexual Abuse 1<sup>st</sup>, and Forcible Touching from an incident in September. He was remanded to the Monroe County Jail.

10/08 An East Rochester Officer observed a vehicle moved from his lane unsafely, upon pulling the vehicle over he realized that the driver had a conditional license due to a previous DWI, and was driving a vehicle without an Interlock device. He was charged with operating a Vehicle with no Interlock Device, Move from Lane Unsafely, and Failure to Provide Insurance. His Conditional Driver's License was confiscated.

10/10 A routine traffic stop yielded a Driver with a revoked learners permit, and suspended registration on the vehicle. While searching the vehicle subsequent to towing it, He also discovered that the male passenger was violating an order of protection by being in the vehicle with the female friend. A silver hand gun was in the glove compartment fully loaded, and the serial number had been defaced. The male passenger was charged with Criminal Contempt, and Criminal Possession of a Weapon. The female driver was issued several Traffic tickets.

10/10 East Rochester Police responded to a report of an unknown person firing a gun in the North side Park. Police located a group of youths, who denied any knowledge of a gun. Upon searching one of the suspects, marijuana was discovered in his pocket. He was charged with Unlawful Possession of Marijuana. A bb gun was found under the park bench. No one claimed ownership the bb gun was taken into custody.

10/11 The Tehnoplex Mall reported that someone put graffiti on the dumpster behind the building overnight.

10/13 Custom Truck Creations of 135 Despatch Drive reported having two of their trucks vandalized in an attempt to steal them. The steering columns of both trucks were damaged and several custom plow controls were missing as well. A technician responded and searched the scene.

10/14 Kaplan Container reported that someone removed the manhole cover at their location.

10/16 Two East Rochester woman started a verbal altercation with each other on w Filbert Street. The woman began to physically fight and roll around in the front yard hitting each other. Both were arrested for Harassment.

10/17 An Automobile accident resulted in one of the drivers being arrested for Aggravated Unlicensed Operator after he ran into the back of a vehicle that was turning left on West Commercial Street.

10/17 Dollar General reported that a man and a woman walked into their store and filled a basket full of dvd's and cd's and walked out without paying. The clerk obtained a license plate number and a broadcast was put out for the vehicle. A deputy in Penfield spotted the vehicle and pulled it over. The male was transported back to East Rochester and charged with Petit Larceny.

10/18 While sitting in her car in a parking lot the driver observed a male walk next to her car with his keys and scratch the side of her car. Police responded, but the suspect had fled the scene. A photo array of suspects was shown to the victim, but she was unable to identify the suspect, and Failure to 10/18 A west Chestnut St. Resident reported some had entered his vehicle and removed his cell phone, speakers and amplifier. No witnesses.

10/20 Police responded to a 911 hang up call and on East Linden Ave., and observed no vehicles in the driveway and several dogs barking inside the residence. Neighbors stated that the residents were older and had not been seen in several days. Fire responded and entrance to the home was gained. The home was filthy and contained the remains of several dead animals. There were also multiple animals alive in cages. The Hazardous Materials Team responded due to the smell in the house, and the Humane society responded and removed the dogs. The Humane society returned later and removed the rest of the animals, and the house was secured by the Village Building department. The homeowners could not be located.

10/21 A routine traffic stop yielded a drug arrest in addition to several traffic tickets.

10/21 The resident of the above condemned property returned home to find his house secured and became irate at the Police Department for securing his property, and was arrested for Disorderly Conduct, and torture and Failure to Feed an Animal.

10/23 An East Rochester Couple was arrested for Trespass as they were walking down the railroad tracks. Both were also charged with Open Container under the Village Ordinance.

10/24 A neighbor trouble resulted in a Harassment arrest for an East Rochester resident. They were arguing over a vehicle blocking a shared driveway. Both the Male and Female victims were pushed by the Suspect. The judge issued an order of Protection for the couple and issued an appearance ticket to the suspect.

The Police backed up the East Rochester Ambulance Corps on 35 calls, and took 333 self- initiated jobs.
